## 4) Matters Arising

- d) Affordable Housing Cllr Mrs P Griffin reported that the Rural Housing Enabler and South Devon Rural Housing Association, are looking at the field on Denbury Down Road. TDC confirmed that 10/11 homes could be possible, mixed housing with houses and bungalows. Some plans will be drawn up so that Villagers can come and have a look and be happy with what will be built before it goes to planning. CCD have confirmed that funding is currently available and a community land trust may be looked into. Some homes will be for rent, some shared ownership and 20% will be open market.
- e) Neighbourhood Plan Cllr Mrs E Heaver reported that a meeting will be held on the 16<sup>th</sup> May which is the last call for more people to come forward to help get the plan off the ground. Letter to go to TDC Rob Kelly to confirm the designated area for the Neighbourhood Plan with a plan enclosed showing the boundaries of the Parish.

- h) Post Office Colin Pound has been e-mailed but nothing further has been heard, the Clerk will ask Colin to come to the next meeting to report on progress.
- i) Denbury Allotments Cllr Mrs E Heaver reported that she met Jim Peck and Tracy Hocking at the Playing Fields, a piece of land at the bottom has been identified giving enough room to get a decent amount of allotments as a first phase (Approx 10), proposed by Cllr R White & seconded by Cllr E Heaver with all in agreement that the possibility of this will be looked into further. Cllr R White will contact Steve Narvidge at the Football Club to see if he will be agreement with this.

Ogwell Parish Council confirmed that they would like to co-operate more with Denbury regards the playing fields. Rural Broadband provision was also discussed at TDC, this would be a point for the Neighbourhood Plan if the Parish so wished.
